ABOUT CHILD DEVELOPMENT RESOURCES





The PC, in partnership with the Board of Directors, is the governing body of the Head Start Program. The PC is responsible for the direction of the program, including making decisions about policies, operating procedures, budgets, and proper adherence to the program guidelines.

Head Start is a national program that promotes the school readiness of children and provides a wide range of services to support the children's mental, social, and emotional development, including support for the entire family.





Child Development Resources Head Start Program provides free (no-cost) child care services/preschool. We serve pregnant women and children ages zero to five years and their families.

Programs offered include:



HEAD START PROGRAM/ CALIFORNIA STATE PRESCHOOL PROGRAM

The program serves low-income three and four-year old children and their families. Program options include Home-Based and Center-Based.



EARLY HEAD START PROGRAM

The program serves low-income infants and toddlers under the age of three and pregnant women. Program options include Home-Based and Toddler Center-Based.



EARLY HEAD START-CHILD CARE PARTNERSHIP PROGRAM

The program serves children ages zero to four years old. Child care providers offer full-day and full-year services to families working full-time, enrolled in school or training program, and that are eligible for subsidized child care and EHS services.

School Readiness Program Goals

The School Readiness Goals are aligned and developed based on the five central domains listed in the Head Start Learning Outcomes Framework, Ages Birth to Five. Listed below are the School Readiness Goals, including a goal for children who are dual language learners.



APPROACHES TO LEARNING

Through Approaches to Learning children will:

- show attentiveness, curiosity, and persistence when engaging in and completing tasks
- take initiative to learn on their own and through their discoveries
- demonstrate creativity through art, science, math, and language



COGNITION

Through Cognition Development children will:

- explore numbers, quantities, shapes, and patterns to gain an understanding of math concepts and operations
- investigate how things work and explore their natural world



LANGUAGE AND LITERACY

Through the **Development of Language and Literacy** children will:

- explore the world of books and reading
- express themselves through emergent writing skills
- learn and use words to communicate what they are thinking, feeling, and doing
- listen to and understand increasingly complex language including the names of common objects and action statements



SOCIAL EMOTIONAL DEVELOPMENT

Through the relationship with caring adults, **Social Emotional Development**, children will:

- · recognize their own feelings and manage them appropriately
- establish and maintain positive relationship with peers and adults
- interact groups with increased competence and confidence
- follow routines and expectations



PERCEPTUAL, MOTOR, AND PHYSICAL DEVELOPMENT

Through Perceptual, Motor Physical Development children will:

 gain greater control and coordination of their hands and bodies so they can learn, explore, create and do simple tasks for themselves



DUAL LANGUAGE LEARNERS

Children who are **Dual Language Learners** will demonstrate increased competency in their home language while developing in English

Early Care and Education Services

Services include early learning education, where instructional staff plan, individualize, assess and record each child's progress and prepare them for kindergarten and life. Children with special needs and disabilities are supported by understanding their unique needs and providing individualized services in collaboration with parents and service providers.

Approach to School Readiness and Head Start Activities

CURRICULUM


The Head Start Program uses Creative Curriculum to support children's learning and development. The Creative Curriculum is research-based and aligns with the Head Start Early Learning Outcomes Framework, Ages Birth to Five.

DEVELOPMENTAL SCREENING AND ASSESSMENTS

The program staff uses the Ages and Stages Questionnaire (ASQ-3) as the developmental screening and the Ages and Stages Questionnaire Social and Emotional, Second Edition (ASQ:SE-2) as the behavioral screening. For the developmental assessment, the program staff utilizes the Desired Results Developmental Profile© 2015 (DRDP [2015]) and Teaching Strategies GOLD®

TEACHING PYRAMID FRAMEWORK STRATEGIES (PROFESSIONAL DEVELOPMENT)

The program staff use Teaching Pyramid Framework Strategies, an evidence-based curriculum, for both soft and intensive coaching. The Teaching Pyramid approach incorporates early childhood Positive Behavior Support to promote healthy social-emotional development, support children's appropriate behavior, prevent challenging behavior and address behavior issues.



Health and Oral Health Services

CDR Head Start services include medical and dental case management to support the family's ability to keep their children healthy and ready to learn. Program staff provide onsite hearing and vision screenings, partner with local dentists to perform onsite visual dental exams, and provide mental health referrals, when appropriate.








2021-2022 Health and Oral Health Program Outcomes:

CDR's Nutrition Services consist of providing Head Start Center-Based children with nutritious meals that include Breakfast, Lunch, and Supplement (Snack) through the Child and Adult Care Food Program (CACFP).

Family and Community Engagement Services

Programs support and strengthen parent-child relationships and engage families in the learning and development of their children. Services include parent engagement activities and leadership opportunities, helping families to meet their needs and achieve goals, and community resources and services.

ENHANCED PARENT WORKSHOP

The family engagement unit hosted virtual parent workshops with key topics identified by the parents. As part of our efforts to provide information and resources, staff resumed inviting guest speakers from various agencies, such as Clinicas del Camino Real, Inc., Montecito Bank, and Interface Children & Family Services. The parent workshops are recorded, allowing the opportunity to share with families who could not participate – providing them access to information. Training topics included but were not limited to: *Preventing Child Abuse and Neglect, Stress Management, Financial Literacy: Budget and Savings, and Transitional Kindergarten.*

PARENT EDUCATION AND LEADERSHIP PROGRAM: "ABRIENDO PUERTAS/OPENING DOORS"

The Head Start Program offered the parenting curriculum, "Abriendo Puertas, Opening Doors." The parenting curriculum is research-based with a focus on leadership and advocacy for families with children ages zero to five. Parents participated in an orientation, attended ten interactive group sessions to strengthen their leadership, knowledge, and support systems, which are all key in preparing their young children for school success. This was facilitated by assisting parents in building strong foundations for their children in reading, math, technology, and more. Through this process parents support each other in utilizing what they are learning and in making what they have learned, a part of their daily life, understanding that they are in powerful positions, as leaders and advocates for their children and families.





FOCUS AREA TWO (FA2) MONITORING REVIEW

In July 2022, the Administration for Children and Families (ACF) conducted a Focus Area Two (FA2) monitoring review of the Child Development Resources of Ventura County, Inc. Head Start and Early Head Start programs.

Program Performance Summary Report

On August 5, 2022, we received a letter from the Office of Head Start (OHS) thanking the governing body, policy council, parents, and staff for their engagement in the review process. Based on the information gathered during the review, our program meets all applicable HSPPS, laws, regulations, and policy requirements.



Purpose: The Focus Area 2 (FA2) review is an opportunity for recipients to demonstrate their effectiveness in implementing a high-quality program to promote positive outcomes and school readiness for children and their families. The review is designed to broaden the Office of Head Start's (OHS) understanding of each recipient's performance and to determine if programs are meeting the Head Start Program Performance Standards (HSPPS) requirements, Uniform Guidance, and the Head Start Act.

Ventura County is one of 58 counties in the State of California, ranked as the 13th populous County in the State. It is bordered by Santa Barbara County, Kern County, and Los Angeles County.



Summary Demographics and Economic Status of Ventura County

Below is a summary of the demographics and economic status of Ventura County. The data is primarily from the United States Census Bureau and other reliable data sources.

- Gender Diversity: 427,008 (50.5 percent) females and 418,591 (49.5 percent) males.
- Race and Hispanic Origin: For people reporting one race, 75.4% were White; 1.8% were Black/African American; 0.8% were American Indian/Alaska Native; 7.2% were Asian; 0.2% were Native Hawaiian/Other Pacific Islander, and 6.0% were some other races. An estimated 42.8% were Hispanic and 44.9% were White non-Hispanic.
- High School Graduates, percent of persons 25 years +: 14.3% do not have a High School Diploma.
- Primary Language and Linguistic Isolation English and Spanish are the primary languages. Spanish was spoken by 30% of people at least five years old; 14.5 percent reported that they did not speak English "very well."
- Unemployment: The unemployment rate in the Ventura County was 3.2 percent in July 2022, unchanged from a revised 3.2 percent in June 2022, and below the year-ago estimate of 6.5 percent.
- Health Insurance status 8.4% of the population under 65 years are uninsured.
- inflation: January Q1 2022 Consumer Price Index showed an increase of 7.53%, representing the highest inflation rate since 1982.
- Housing/Rent: A recent study by California Housing Partnership, found that the asking rents in Ventura County increased by 13% between Q4 2020 and Q4 2021.
- Community Need: Based on the 2-1-1 data, the top three needs were 1) Housing, 2) Mental Health/Addiction, and 3) Income Support/Assistance.



<u>Children Below Poverty Level (Under Five Years of Age)</u> 11.6% (5,705 out of the 49,179) of children under five years of age are living below poverty level.

Families Below Poverty Level

8.9% (75,258 out of 845,599) of the population are living with income below the poverty level.

Women Below Poverty – Gave Birth in the past 12 months 14.99% (1,437 out of 9,584) of women living below the poverty level in Ventura County who had given birth in the past 12 months.

SUBSIDIZED CHILD CARE PROGRAMS

Child Development Resource administers various subsidized child care programs, which include the following:



CalWORKs CHILD CARE

The CalWORKs Child Care Program is administered by CDR and helps families access immediate, quality, and affordable child care as they move through the Welfare-to-Work activities towards employment and self-sufficiency, and move off of cash assistance. The CalWORKs Stage 1 Program is funded through the California Department of Social Services, Ventura County Human Services Agency. The CalWORKs Stages 2 and 3 Programs are funded through the California Department of Social Services (CDSS), Child Care and Development Division (CCDD).



ALTERNATIVE PAYMENT PROGRAM

The Alternative Payment Program (APP), funded with state and federal funds, offers an array of child care arrangements for parents, such as in-home care, family child care, and center-based care. The APP helps families arrange child care services and makes payment for those services directly to the child care provider selected by the family. The APP is intended to increase parental choice and accommodate the individual needs of the family. Eligibility for this program is based on income and need.



FAMILY CHILD CARE HOME EDUCATION NETWORK INFANT TODDLER

The Family Child Care Home Education Network (FCCHEN) Program offers affordable child care assistance to eligible parents. The program provides quality child care through supportive relationships between children, parents, family child care home providers, and CDR program specialists. Funded by the California Department of Social Services (CDSS) Child Care and Development Division (CCDD), the family child care home providers enrolled receive ongoing professional development training, guidance, and technical support from CDR program specialists to ensure high-quality child development services.




CHILD CARE BRIDGE PROGRAM FOR FOSTER CHILDREN

The Bridge program offers time-limited child care assistance designed to increase the number of foster children successfully placed in home-based family care settings, increase capacity of child care programs to meet the needs of foster children in their care, and maximize funding to support the child care needs of eligible families. Services include enhanced referrals and short-term child care subsidy. In addition, CDR provides Trauma Informed Care Training to child care providers who are caring for foster children placed in their program. Services are funded by the California Department of Social Services, Ventura County Human Services Agency, Children and Family Services Division.



Below is the number of children who received subsidized child care services for each program.




Waitlist/Need Subsidized Child Care Services

CHILD CARE RESOURCE AND REFERRAL PROGRAM

What is Child Care Resource and Referral Services?

Child Care Resource and Referral agencies (R&R) are state-funded, community-based programs that exist in every county in California. R&Rs make up a well-developed system that supports parents, child care providers, and local communities. The California Department of Social Services (CDSS), Child Care and Development Division (CCDD) supports R&R agencies throughout the state, including CDR in Ventura County.

CDR offers the following services and resources to Parent and Child Care Providers:

- Parent/Family Resources and Services
- Provider Training and Resources



CHILD CARE RESOURCE AND REFERRAL PROGRAM

Parent/Family Resources and Services

CDR Child Care Resource & Referral Program staff provides information to parents/families and the community about the availability of child care in Ventura County. It also provides educational and leadership opportunities to parents by offering trainings and hosting gatherings, such as the Parent Café series.

Child Care Resource and Referral Program

Provider Grants to Support Child Care Providers

State Budget Assembly Bill AB 131 and Senate Bill SB 820 allocated funds for child care providers serving families in a subsidized child care program. Funds intended to be used to support child care providers with COVID-19 pandemic relief, and, in the case of decreased enrollment or closures, to support child care providers in remaining open or reopening. CDR issued \$2,067,828 to 696 licensed and family friend and neighbor child care providers. In addition, CDR received a grant from the California Department of Social Services in the amount of \$351,925. A total of 347 child care providers received instructional materials developmentally appropriate to support art, exploration, creativity, utilization of construction blocks, dramatic and pretend play, development of fine motor skills/use of manipulatives to enhance thinking and reasoning, appreciation of music and movement, the development of gross motor skills, exploration of science and nature, encourage sensory-rich activities, and support language and literacy learning.

Provider Training

Listed below are some of the types of training and workshops offered throughout the year.

Child Care Initiative Project

The project provides free training and support for new and existing licensed family child care home providers. Services include pre-licensing home visits, workshops/training, support and guidance, networking opportunities with other family child care providers, marketing strategies, and educational incentives.



Preventative Health and Safety Practices Training

The grant provides reimbursement for initial and renewal of CDR/First Aid training courses completed by licensed center-based, family child care and license-exempt child care providers.



Health & Safety Reimbursement Grant

Free eight-hour Prevention Health and Safety training for persons seeking a center or family child care license in Ventura and Santa Barbara counties, includes a one-hour nutrition topic.



Provider Resources

The Resource & Referral (R&R) Unit throughout the year has distributed essential supplies to child care providers at CDR's central office. The R&R staff provided PPE supplies to over 600 child care providers through August 2021 and June 2022. Providers received hand sanitizer, gloves, masks, and disinfectant. In addition, R&R set up deliveries of COVID-19 Test Kits to over 400 providers.




OUR WORKFORCE



EMPLOYEE DEMOGRAPHICS




EMPLOYEE EDUCATION ATTAINMENT




