



Board of Directors

They are legally and financially accountable for all agency activities, including policymaking, annual budget approval, and determining the direction and objectives of the agency and its programs.



Policy Council

The Policy Council (PC) consists of 30 members, that include Head Start parents and community representatives. The PC, in partnership with the Board of Directors, is the governing body of the Head Start Program. The PC is responsible for the direction of the program, including making decisions about policies, operating procedures, budgets, and proper adherence to the program guidelines.

What is Head Start?

Head Start is a nationwide program that focuses on preparing children for school while also offering a variety of comprehensive services to promote their mental, social, and emotional development.





Introducing the CDR Head Start Program:

The CDR Head Start Program offers free childcare services and preschool programs for families with children aged zero to five years old, including expectant mothers. We provide the following programs:

- Head Start Program/California State Preschool Program:
 - This program is designed to serve low-income families with three and four year children in a center or home-based options.
- Early Head Start Program:

This program serves low-income pregnant women, infants, and toddlers under the age of three in a toddler center-based or home-based option.

Early Head Start-Child Care Partnership Program:

This program serves families with children ages zero to four years old. Childcare providers offer full-day and full-year services to families who are working full-time or are enrolled in a school or training program. Families enrolled in this program must be eligible to receive subsidized child care services.

Comprehensive Services

What sets us apart from other programs is our comprehensive services that promote and support our enrolled children and families. We offer health and nutrition services and specialized services for children with disabilities and mental health concerns. We work in partnership with families as they learn to serve as their children's lifelong advocates and provide strategies to promote their well-being and engagement.

Services include:



Early Care and Education Services

Empowering Children and Families for Lifelong Learning

Our approach to lifelong learning involves utilizing a research-based curriculum and teaching social-emotional skills through individualization and strong family partnerships. We cater to each child's unique learning style to make education fun and meaningful!



Disability (Inclusive) Services

Empowering Children with Disabilities through Our Inclusive Program

Our Inclusive Program provides individualized services to children with disabilities or developmental delays. We work closely with parents and other service providers to understand their unique needs and ensure that they receive the support they need to succeed.



Health Services

Supporting Children's Health and Wellness Through Collaborative Care

We collaborate with families to ensure that children receive prompt medical and oral health care when needed. We also assist families and children with their mental and emotional well-being to promote overall health and wellness. Healthy children are not only happier, but they are also better prepared to learn.



Nutrition Services

The Importance of Healthy Eating for Children

Providing children with healthy meals and snacks is crucial for their overall well-being. This fuels their growing minds and bodies and ensures they receive the proper nutritional intake. We carefully review each child's nutritional needs to ensure they are offered a balanced diet.



Family Support Services

Partnering with Families to Achieve Their Goals

Our organization collaborates with families to identify their strengths and areas needing attention. Our focus is on providing families with the resources they need to understand their child's education and advocate effectively for their needs. We work together to set goals that improve the overall well-being of their family.

Early Care and Education Services

Services include early learning education, where instructional staff plan, individualize, assess and record each child's progress and prepare them for kindergarten and life. Children with special needs and disabilities are supported by understanding their unique needs and providing individualized services in collaboration with parents and service providers.



Approach to School Readiness and Head Start Activities

Curriculum

The Head Start Program uses Creative Curriculum to support children's learning and development. The Creative Curriculum is research-based and aligns with the Head Start Early Learning Outcomes Framework, Ages Birth to Five.

Developmental Screening and Assessments

The program staff uses the Ages and Stages Questionnaire (ASQ-3) as the developmental screening and the Ages and Stages Questionnaire Social and Emotional, Second Edition (ASQ:SE-2) as the behavioral screening. For the developmental assessment, the program staff utilizes the Desired Results Developmental Profile© 2015 (DRDP [2015]) and Teaching Strategies GOLD®

Teaching Pyramid Framework Strategies (Professional Development)


The program staff use Teaching Pyramid Framework Strategies, an evidence-based curriculum, for both soft and intensive coaching. The Teaching Pyramid approach incorporates early childhood Positive Behavior Support to promote healthy social-emotional development, support children's appropriate behavior, prevent challenging behavior and address behavior issues.

Overview of School Readiness Goals

The School Readiness Goals were created by the Education Unit in 2019 and reviewed and approved by the Policy Council and Board of Directors. These goals are based on the Head Start Early Learning Outcomes Framework (ELOF) and are aligned with the five central domains for children aged from birth to five years. Additionally, the goals incorporate a specific objective for Dual Language Learners.

Below is a brief summary of each of the five domains, including the objective for Dual Language Learners:

- Approaches to Learning: Children will be encouraged to show attentiveness, curiosity, and persistence when
 engaging in and completing tasks. They will also be taught to take the initiative to learn and explore on their
 own, as well as to demonstrate creativity through art, science, math, and language.
- Cognition Development: Children will explore numbers, quantities, shapes, and patterns to gain an understanding of math concepts and operations. They will also be encouraged to investigate how things work and explore the natural world.
- Language and Literacy: Children will be taught to express themselves through emergent writing skills, learn and use words to communicate their thoughts, feelings, and actions, as well as listen and understand increasingly complex language, including the names of common objects and action statements.
- **Social Emotional Development:** The focus will be on the relationship between children and caring adults. Children will be taught to recognize their own feelings and manage them appropriately. They will also be encouraged to establish and maintain positive relationships with peers and adults, interact in groups with increased competence and confidence, and follow routines and expectations.
- Perceptual, Motor, and Physical Development: The focus will be on helping children gain greater control and coordination of their hands and bodies, enabling them to learn, explore, create, and do simple tasks for themselves.
- **Dual Language Learners:** For children who are Dual Language Learners, these goals will help them demonstrate increased competency in their home language while developing in English.



Health and Oral Health Services


CDR Head Start services include medical and dental case management to support the family's ability to keep their children healthy and ready to learn. Program staff provide onsite hearing and vision screenings, partner with local dentists to perform onsite visual dental exams, and provide mental health referrals, when appropriate.



Health Services for Enrolled Children


As part of our case management, we ensure that enrolled children have access to medical and dental insurance as well as receive regular medical and dental exams. For the 2022-2023 School Year, we have achieved the following percentages for children who are up-to-date with age-appropriate preventive and primary health care, in accordance with California's Early and Periodic Screening, Diagnostic, and Treatment (EPSDT) schedule for well-child care.

Nutrition Services

CDR's Nutrition Services consist of providing Head Start Center-Based children with nutritious meals that include Breakfast, Lunch, and a Supplement (Snack) through the Child and Adult Care Food Program (CACFP). In addition, program staff co-empower and educate parents to make healthy choices for themselves and their children. As part of the nutrition program, we evaluate each child's nutritional needs and provide healthy meals and snacks.

During the 2022-2023 program year, the program staff partnered with nine local dentists to conduct 487 onsite visual dental screenings at our Head Start Centers.






Parent Night Workshop


Abriendo Puertas/Opening Doors, Parenting Curriculum





What is the Program Information Report (PIR)?

The Program Information Report (PIR) is a comprehensive report that contains data on Head Start and Early Head Start programs across the United States. This report is used at the federal, regional, state, and local level. The PIR report collects data on child, staff, and family demographics and program characteristics. It also gathers information on physical health, mental health, disabilities, and family services.

Our agency is required to collect and report this information to the Office of Head Start as part of our Head Start and Early Head Start programs. The data on this page combines general demographic information for all three CDR Head Start Programs (Head Start, Early Head Start, and Early Head Start-child Care Partnership) submitted as part of the PIR report.

Summary Demographics and Economic Status of Ventura County


Below is a summary of Ventura County's demographics and economic status, sourced primarily from the United States Census Bureau 2017-2021 American Community Survey 5-Year Estimates and other reliable sources.

- Gender Diversity: 424,655 individuals (50.2 percent) are female, and 420,600 individuals (49.8 percent) are male. The median age of the population is 38.7 years.
- Race and Hispanic Origin: For people reporting one race, 70.1% were White; 1.8% were Black/African American; 1.1% were American Indian/Alaska Native; 7.3% were Asian; 0.2% were Native Hawaiian/Other Pacific Islander, and 6.9% were some other races. Around 43% were Hispanic, and 44% were White non-Hispanic.
- High School Graduates, percent of persons 25 years +: 14.3% do not have a High School Diploma.
- Primary Language and Linguistic Isolation English and Spanish are the primary languages. Spanish was spoken by 29.8% of people at least five years old; 14.3% reported that they did not speak English "very well."
- Medium Household Income: The median income was \$94,150.
- Unemployment: The unemployment rate was 3.7% in May 2023, up from a revised 3.6 percent in April 2023 and above the year-ago estimate of 3.0 percent.
- Households with Housing Cost Burden: 38.6 percent of owners and 59.1 percent of renters. (Households that pay 30% or more of their income on housing costs.)
- Homelessness: The count of homeless individuals in 2018 was 1,299, and in 2023, it rose to 2,441, showing an increase of 1,142 people or 87.9%.
- Health Insurance Status: 8.4% did not have health insurance coverage.
- Disability Rate: 11% of the population reported a disability, varying by age, with 4.3% for people under 18. For children under the age of five, speech and language impairment were among the highest percentages of the diagnosed disability type.
- Health Concerns: Mental Health was ranked as the most important health problem within the community based on the "2022 Community Health Assessment."

Individuals Living Below Poverty Level

In Ventura County, 8.9 % (74,645 out of 847,263) of the population has an income below the poverty level.

- Families Below the Poverty Level is 6.2%
- Children Below the Poverty Level are 12.3%
- · Children Under Five Years of Age
 - 11.4% (6,012 out of the 50,525) of children under five years of age are living below the poverty level.
- Women living below the poverty level who gave birth in the past 12 months was 14.99% (1,437 out of 9,584)

Subsidized Child Care Programs

Child Development Resource administers various subsidized child care programs that are funded by the California Department of Social Services (CDSS). Below is the a list of program offered.

CalWORKs Child Care

The CalWORKs Child Care Program is designed to help families obtain affordable and high-quality child care services while transitioning from the Welfare-to-Work activities towards employment and self-sufficiency. This program also assists families in moving away from cash assistance.

Alternative Payment Program

The Alternative Payment Program (APP) provides a range of child care options for parents, including inhome care, family child care, and center-based care, using state and federal funding. The program helps families find and pay for child care directly to the provider selected by the family. The APP is designed to enhance parental choice and cater to the specific needs of each family. Eligibility for the program is determined based on the family's need and income.

Family Child Care Home Education Network Infant Toddler

The Family Child Care Home Education Network (FCCHEN) Program provides assistance to parents who meet specific eligibility requirements. The program focuses on fostering strong relationships between children, parents, family child care home providers, and CDR program specialists to ensure high-quality child care. Enrolled family child care home providers receive ongoing professional development training, guidance, and technical support from CDR program specialists.

Child Care Bridge Program for Foster Children

The Bridge program offers specialized child care assistance for a limited period to foster children. The program is aimed at increasing successful placement of foster children in home-based family care, enhancing the capacity of child care programs to meet the unique needs of foster children, and maximizing funding to support eligible families. Some of the services offered include enhanced referrals, short-term child care subsidy, and Trauma Informed Care Training for child care providers who are caring for foster children.



Child Care Resource and Referral Services

Resource and Referral (R&R) programs provide invaluable support to families, child care providers, and local communities. Funded by California Department of Social Services, the R&R programs offers a variety of resources on early care and education for those looking for child care or operating a child care program.

CDR offers a variety of resources and services to both parents and child care providers, such as:

- Parent/Family Services and Resources
- · Training and Resources for Providers.

Parent & Family Resources and Services

R&R program staff provides information to families and the community about the availability of child care in Ventura County. Services include education on choosing child care, connecting to resources, and community connections by offering trainings and Parent Café series.

Child Care Resource and Referral Program

The program offers complimentary child care referrals to all parents. Our Resource & Referral Specialists assist parents in locating a suitable, reasonably priced, and convenient child care program that caters to their family's specific requirements.

CHILD CARE RESOURCE AND REFERRAL PROGRAM

Provider Training

CDR Child Care Resource & Referral Program staff offers training to new and existing child care providers on a variety of topics. The program's goal is to improve and strengthen the quality of child care in Ventura County.





Listed below are some of the types of training and workshops offered throughout the year.

- Child Care Initiative Project
 - The Child Care Initiative Project (CCIP) provides free training and support for new and existing licensed family child care home providers. Services include pre-licensing home visits, workshops/training, support and guidance, networking opportunities with other family child care providers, marketing strategies, and educational incentives.
- Preventative Health and Safety Practices Training
 The grant provides reimbursement for initial and renewal of CDR/First Aid training courses completed by licensed center-based, family child care and license-exempt child care providers in Ventura and Santa Barbara counties.
- Free eight-hour Prevention Health and Safety training for persons seeking a center or family child care license in Ventura County, includes a one-hour nutrition topic.

Provider Grants to Support Child Care Providers

State budget bills AB 179 and SB115 allocated American Rescue Plan Act funds for child care providers serving families in a subsidized child care program. Funds intended to be used to support child care providers with COVID-19 pandemic relief, and, in the case of decreased enrollment or closures, to support child care providers in remaining open or reopening. CDR issued \$4,164,496 for AB 179 to 2,888 licensed and family friend and neighbor child care providers. CDR issued \$776,782 for SB115 to 316 licensed child care centers.







Supplies and COVID-19 Test Kits for Child Care Programs

The Resource & Referral (R&R) Unit throughout the year has distributed essential supplies to child care providers at CDR's central office. The R&R staff provided PPE supplies to over 300 child care providers through July 2022 and June 2023. Providers received hand sanitizer, gloves, and masks. In addition, R&R set up deliveries of COVID-19 Test Kits to over 60 Small Family Child Care Homes.



Year at a Glance




